The Mackay Community Foundation provides an opportunity for individuals, families and businesses to make donations to support those in need in the region, both now and in the future.

Subject to any legal requirements for minimum annual distributions, donations are retained as capital by the Foundation to build a perpetual and sustainable fund for philanthropic purposes.

The income earned from the capital is distributed through our annual grants program. Not for profit organisations in the region apply for grants to fund charitable projects that align with the aims of the Foundation.

The Mackay Community Foundation is endorsed by the Australian Tax Office as a charity and by the Queensland Office of Fair Trading as fundraising for a charitable purpose. Donations to the Foundation are tax deductible and our organisation is exempt from tax.

The Foundation is governed by a volunteer Board of Directors with a wide range of skills, experience and extensive knowledge of the region's community.

CHAIR'S REPORT – 2021/2022

In February 2022, we were delighted to receive the largest donation to date in the Foundation's 19-year history. This donation was a commercial building, 7 Gregory Street, in the Mackay Central Business District. David Denny, a past Mackay businessman, had sought our interest in obtaining this building and, after much consideration from the Board and due diligence, we accepted David's generous offer.

After taking on the commercial property, Explore Commercial Property assisted us in seeking a new tenant for the first floor. Within two months of owning the building, we welcomed Rimex Wheels, a global company, to the tenancy whilst long term tenants, Hearing Australia, are on the ground floor. All net rental income will be going back to the community.

With this donation, we will see the past grant giving go from \$73,000 in 2022 to an estimated \$120,000 in 2023. This shows how important it is for the community to continue to build the corpus, to ensure we can continue to increase the grant giving for non-profit organisations helping individuals in need.

Also to ensure this transaction of the commercial building went ahead, the Foundation received a significant amount of support from local businesses and individuals, and we have noted our thanks to all involved on page 13.

In February, we celebrated the installation of the "Honour Wall". This Wall stands in the entrance foyer of the Dudley Denny

As Board of Directors Chair, it is my privilege to inform our supporters and donors that the 21/22 year is one to go down in the history books for the Mackay Community Foundation.

City Library and the space was offered by Mackay Regional Council for us to honour the Foundation's "named fund" donors and in-kind support provided in excess of \$10,000. The Honour Wall gives us the opportunity to say thank you to our donors but also gives the Foundation further brand awareness in the public eye. OUR HISTORY

The concept for the Mackay Community Foundation began with our founder Scott Alman in 2002. Scott, a partner in a local investment advisory firm, was discussing the story below and thought about the impact if someone had put away money for Mackay 100 years ago.

In 1626, Peter Minuit purchased Manhattan Island from the Algonquin tribe of Indians for trinkets worth about \$24. Given the price of real estate in Manhattan today, we could argue that the Indians were swindled. However, let's assume that the Indians invested the \$24 in a bank account returning 6% per year compounded annually.

In 2005, after 379 years, the investment would be worth \$66 billion.

The key founding principle was to give the Mackay community the opportunity to 'Give where you live'. Secondly, that money donated would be invested and, together with the growth, the capital would be retained in perpetuity. Each year the growing income could be given as grants to not-for-profit organisations to assist those in need in our community.

Scott then set about inspiring other key business and community leaders to join the Foundation's Board. The founding Board members were; Solicitor Andrew Coates, Accountant Wayne James and Financial Planner Stephen Lowry, with Scott Alman as the Chair. Since the beginning, the sitting Mayor of Mackay has also held a position on the board.

AT A GLANCE

Since our establishment, we have distributed **87** grants to local not-for-profit organisations.

The Mackay Community Foundation is a member of Community Foundations Australia and is one of approximately 45 community foundations across Australia, linked by similar values, ethics and intent – each playing a vital role in their own community, providing grassroots support at a local level.

The Mackay Community Foundation provides support to local community groups and charities in the Mackay region, which is an area encompassing a population of approximately 120,000 people. We work extremely hard to ensure administrative expenses are kept to a minimum and, where possible, source donated services and support. Fifteen percent of each dollar donated to the Foundation is directed to the administration account to assist with the costs associated with enabling the Foundation to deliver its mission:

GRANTS COMMITTEE REPORT – 2021/2022

Our 21/22 grant round was offered in March-April, inviting applications for projects ranging \$10,000-\$30,000 to allow an organisation to look at actual program development, capacity building and innovative approaches to bring about social change and positive impact for those experiencing disadvantage.

The Foundation's grants program provides funds to help, aid, provide relief or support to persons in distress in Mackay and surrounding districts. We do this by working with eligible organisations that primarily offer community education, care services, housing or personal support services.

In 21/22, the Foundation provided grants in total of \$73,000 to organisations who provide a range of community services – including healthcare, support for people who are differently abled, community development, women's services and youth support.

Lowanna House Inc

Grant: \$25,630

Purpose: Funded the installation of a 6.66KW solar system and air conditioning in each of the bedrooms, lounge and dining areas of a dwelling that houses families in need of short-term accommodation. The installation of solar panels and battery storage ensures no significant additional expenses in electricity into the future but, most importantly, provides comfort in the hotter months in Mackay to the many families utilising this dwelling.

Phoenix Place Inc

Grant: \$20,000

Purpose: Funded 120 participants from community groups, small not-for-profit organisations and volunteer groups to attend an internationally recognised accredited “Mental Health First Aid” Course. These individuals now have the skills, knowledge and confidence to assist someone who may be experiencing a mental health problem or mental health crisis. They will be able to recognise the warning signs of mental health problems, and intervene early. They have learned the skills needed to speak openly and accurately about mental health, are able to respond in crisis situations where a person may be at risk of harm, can provide increased support for people with mental health problems and will be an important part of reducing the stigma around mental health.

Crossroad Arts Inc

Grant: \$11,000

Purpose: Supported the “Access to All” arts program, which will be completed by June 2023. The aim is for Crossroad Arts to implement more accessible initiatives for our community, which also helps to promote Mackay as an inclusive arts and cultural destination. This grant will support the delivery of Auslan interpreting, alternate formats like braille, easy read captioning and audio description throughout the program, including the major production.

CASA

Grant: \$11,370

Purpose: Assisted with expenses for the Homelessness Expo 2022, which returned for its 10th year. This Expo was held on 2 June 2022 in aid of the following:

- > Heighten community’s awareness of homelessness in the Mackay Regional Council area.
- > Improve community’s understanding of homelessness and the impact on social aspects of society.
- > Enhance opportunities for people experiencing homelessness to engage with government and non-government organisations to access additional support and/or source solutions to issues that impede them being housed.
- > Provide useful services and products for people currently without housing, such as haircuts, food packs, toiletry packs, raincoats, torches, blow-up pillow and blankets and clothing.

CQUniversity

Grant: \$5,000

Purpose: Contribute to CQUniCares Emergency Grants, which provide financial assistance to low-income students who experience unexpected financial hardship as a result of an emergency or unforeseen situation that has the potential to derail their studies. The funds are used to support vocational education and training (VET) and higher education (HED) students living and studying in the Mackay region.

NAMED FUNDS

Named Fund is ideally suited to an individual, family or business wishing to provide support to a range of charities and community groups in Mackay – to leave an ongoing legacy to the community, or honour a family member, friend or outstanding citizen. They are an alternative to Private Ancillary Funds (PAF), offering some very real benefits to the donor – such as:

- Funds are referenced and acknowledged in the name specified by the donor. This can be an individual, partners, family names, a business name or in the memory of someone.
- The fund is named from the outset, although the initial minimum contribution can be made over a period of years.*
- The donor can participate in the fund as little or as much as they desire.
- Ongoing contributions, whilst not essential, are recommended at least for a few years.
- Donations to the fund are tax deductible.
- Named fund donors can be involved in presenting grants from the fund, if they wish.
- The fund continues into perpetuity, even after the donor's passing.

Donors may indicate a preference that a particular group or type of eligible projects benefit from its donation. We are happy to discuss this or any other options with you, confidentially and totally obligation free.

*The minimum contribution is \$11,500 over three years.

7 GREGORY STREET

The building at 7 Gregory Street, formerly owned by Denny Investments Pty Ltd – a long-term member of and investor in the Mackay district, will now be known as “Foundation House”. Mr David Denny, a director of the company, provided the following comment.

“When one is considering estate planning matters, lots of ideas are floated. A practical suggestion often made is to “include a charity in your Will”. This concept has always appealed to me but the selection of a “charity” is not as easy as it may seem. By deciding to assist the Mackay Community Foundation, this problem is solved. The Foundation is well established, well managed and most importantly can direct assistance where it is most needed from time to time. Equally importantly, one knows that the assistance afforded to others in the future will go to people and organisations in the Mackay region.”

In saying this, Mr Denny notes that in no way do his words take away from the admiration for the ongoing, outstanding work being done by other Foundations in Mackay.

For the historians, this building was designed by Sanders Turner Ellick Architects and built in the late 1990's by Fergus Builders. For a very long time, the site was the Mackay home of the Australian Workers Union (AWU) and a plaque in the footpath attests to this. At present, this building is tenanted on the ground floor by Hearing Australia and Rimex Wheels on the first floor. Their net rent is then invested back into the Foundation, to further contribute to worthwhile causes in our local community.
