### CHAIR'S REPORT

What a privilege to be part of a non-profit organisation that has a vision of helping now but also into the future. A way for our community to leave a legacy for generations to come. The Mackay Community Foundation board's role is to continue to build the pool of funds to ensure that the Foundation can provide an ever-increasing income for people in need or vulnerable in our community. To this, donations combined with the growth on the investments for the year, saw the pool of funds increase by \$164,439 to a value of \$3,301,936.

It was with great pleasure that the Foundation realised two further milestones this year. The first, seeing the grant giving go from \$73,000 in the 2021/2022 financial year to \$169,000 this year. The two factors that drove this increase were an increased income derived from the diversified portfolio and the addition of the commercial property that generated a full year's worth of net rental income. The Foundation is committed to giving all net income derived from these investments back to the community.

The second milestone was that the increase in grant giving gave the Foundation the ability to meet a great need in our community, which is a safe place to sleep, and provide the largest grant in the 21-year history of the Foundation. A grant of \$75,000 to Australian Street Aid Project for assistance to purchase a PINK Sleepbus for women and children to have a safe place to sleep. Further information on this project and the other 7 worthy grants we provided this year are on pages 8 - 10.

Thank you to all our donors, you are unquestionably living the vision of the Foundation, by Giving Where You Live.

If you are not yet a donor of the Foundation and wish to join us in achieving our target of seeking \$10 Million in funds for our community by 2040 or earlier, which will provide at least \$500,000 in grants to those in need each year, then speak with one of our board members.

### **OUR HISTORY**

The concept for the Mackay Community Foundation began with our founder Scott Alman in 2002. Scott, a partner in a local investment advisory firm was discussing the story below and thought about the impact on the needy if someone had put away some money for Mackay 100 years ago.

In 1626, Peter Minuit purchased Manhattan Island from the Algonquin tribe of Indians for trinkets worth about \$24. Given the price of real estate in Manhattan today, we could argue that the Indians were swindled. However, let's assume that the Indians invested the \$24 in a bank account returning 6% per year compounded annually.

In 2005, after 379 years, the investment would be worth \$66 billion.

The key founding principal was to give the Mackay Community the opportunity to 'Give Where You Live'. Secondly that money donated would be invested, and together with the growth, the capital would be retained in perpetuity. Each year the growing income is to be given away to community groups, and projects, to assist those in need in our community.

Scott then set about inspiring other key business and community leaders to join the board of the Foundation. The founding board members were; Solicitor Andrew Coates, Accountant Wayne James and Financial Planner Stephen Lowry, with Scott Alman as the chair. Since the beginning the sitting Mayor of Mackay has also held a position on the board.

### **AT A GLANCE**

Since our establishment, we have distributed **95** grants to local community groups and charities.

The Mackay Community Foundation is a member of Community Foundations Australia and is one of approximately 45 community foundations across Australia, linked by similar values, ethics and intent and each playing a vital role in their own community providing grassroots support at a local level.

The Mackay Community Foundation provides support to local community groups and charities in the Mackay region which is an area encompassing a population of approximately 120,000 people.

The Mackay Community Foundation works extremely hard to ensure administrative expenses are kept to a minimum and where possible source donated services and support.

## GRANTS COMMITTEE **REPORT** -2022/2023

## **Grants**

Our 2022/2023 grant round invited applications from local non-profit organisations for projects that look at actual program development, capacity building and innovative approaches to bring about social change and positive impact for those experiencing disadvantage.

The Foundation's grants program provides funds to help, aid, provide relief or support persons in distress in Mackay and surrounding districts. We do this by working with eligible organisations that primarily offer community education, care services, housing or personal support services, through a grant application process.

In 2022/2023, the Foundation provided a total of \$168,165 to a range of community services - including healthcare, support for people who are differently abled, community development, homeless services and youth support.





### **Australian Street Aid Project – PINK Sleepbus** Grant: \$75,000

**Purpose:** The PINK Sleepbus will provide women and children with a safe place to sleep at night. Whilst this is a short-term solution for the homeless, it will provide much needed respite. The PINK Sleepbus is expected to arrive in Mackay by June 2024.



# **Grant: \$20,000**

**Purpose:** The River 2 Reef Ride For Young People took a group of 10 disadvantaged young people and trained the participants up to successfully complete the River 2 Reef 30km ride in October 2023. The aim of the project was to build a sense of participation and community amongst the group and to develop teamwork and communication strategies that enforce positive outcomes. The facilitators of the program offered positive role modelling behaviour and an understanding around change/community expectations of young people in our society. Successful participants of the program got to keep the bike.





## **Widney Support** Network - Vehicle

### Grant: \$28,545

**Purpose:** This grant replaced an aging vehicle that assists in transporting renal patients to and from hospital appointments and for dialysis three times per week.

### Ronald McDonald House Charities North Aust. – Tutoring Program / Grant Grant: \$14,400

**Purpose:** These funds have gone towards tutoring hours for local students. The aim is that each student achieves improved numeracy and literacy skills and to make the journey back to school as smooth as possible after missing such a large amount of schooling due to cancer treatment. This tutoring will provide a much-needed boost to their confidence and self-esteem.



### Wackay Community Visitors Association (MCVA) – IT Hardware Grant: \$5,500

**Purpose:** 2 desktop computers, new printer and server were purchased to allow MCVA to continue to operate to the highest possible standards with their work connecting the elderly of the region.



# Crossroad Arts - LOOSE ENDS Event

#### Grant: \$10,000

**Purpose:** These funds provided assistance in venue hire, artists, artist support and an AUSLAN interpreter for the 2023 LOOSE ENDS Event. LOOSE ENDS was part of celebrations for International Day for People with Disability. LOOSE ENDS is a crowd favourite event and a fantastic way to close off a year of creativity in a fun and kooky way. This event was initiated in 2018 to address the gap for inclusive night-time activities in the CBD for young people with disability. It was also designed to be a place for people to socialise, be entertained and have opportunities to meet new and different people. The evening features performances from Strictly Wheelchair Dance Group, With One Voice Choir, Choir of Unheard Voices, Groove Movers, live painters, poets and Crossroad Arts performers. For many groups, the LOOSE ENDS evening is an event to work towards to celebrate diversity, access and inclusion.

### 🖓 Phoenix Place Inc. – **Equity Driving Program** Grant: \$9,720

Purpose: The grant has funded the modification of a vehicle and training of an existing gualified driving instructor to provide local access to specialised driving lessons for people with a disability.

Objectives and aims are to provide local opportunity for people with a disability to enhance and improve their independence, participation and employability and reduce their reliance on family carers and paid carers.

There is no service in Mackay at present and people need to travel to Townsville, or Rockhampton as the closest points for driver training.



### CQUniversity – **Emergency Funding** Grant: \$5,000

Purpose: The \$5,000 has been used to contribute to CQUniCares Emergency Grants. These grants provide financial assistance to low-income students who experience unexpected financial hardship as a result of an emergency or unforeseen situation that has the potential to derail their studies. The funds are used to support vocational education and training (VET) and higher education (HED) students living and studying in the Mackay region.

- The fund is named from the outset, although the initial minimum contribution can be made over a period of years.\*
- The donor can participate in the fund as little or as much as they desire.
- Ongoing contributions, whilst not essential, are recommended at least for a few years.
- Donations to the fund are tax deductible.
- Named fund donors can be involved in presenting grants from the fund if they wish.
- The fund continues into perpetuity, even after the donor's passing.
