The Mackay Community Foundation provides an opportunity for individuals, families, and businesses to make donations to support those in need in the region, both now and in the future.

Donations are retained as capital by The Foundation to build a perpetual and sustainable fund for philanthropic purposes. The income earned from the capital is distributed through our annual grants program. Not for profit organisations in the region apply for grants to fund charitable projects that align with the aims of the Foundation.

The Mackay Community Foundation is endorsed by the Australian Taxation Office as a charity. Donations to The Foundation are tax deductible and The Foundation is exempt from tax.

The Foundation is governed by a volunteer Board of Directors, with a wide range of skills, experience and an extensive knowledge of the region's community.

CHAIR'S REPORT

It is with great pleasure that I share the continued progress of the Mackay Community Foundation as we work towards our ambitious goal of securing \$10 million in funds for our community by 2040 or hopefully, even earlier. Our dedicated volunteer Board remains committed to building and managing this growing pool of funds, ensuring we can provide sustainable financial support to those most in need.

Over the past year, a combination of generous donations and investment growth has increased our fund by \$278,765, bringing its total value to \$3,580,703.

Reflecting on our mission, I am continually reminded of the critical role that volunteers and employees in non-profit organisations play. Their work is invaluable, and our responsibility is to ensure they have the financial support to focus on what they do best, helping individuals and families in need. The Foundation operates a smart, sustainable model: we invest donations, which generates income, this income is distributed to non-profits annually, thus ensuring that all donations provide enduring community impact.

In a remarkable development, the Foundation has been blessed with an extraordinary opportunity in the 2024/2025 financial year. An anonymous donor pledged to match, dollar-for-dollar, all individual and business donations of \$5,000 or more, up to a total of \$150,000. This generous offer not only amplifies the impact of each donation but also serves as an encouragement for our community to give a little more, knowing their contributions will go even further. With this initiative, we have the potential to significantly boost our funding and grant-giving capacity. The outcome and benefit of this matched donation will be reflected in the next annual report.

The impact of our growing fund is already being felt. Historically, the Foundation has not had enough funds to meet all grant applications received. However, this year, we were able to approve every application that met our criteria, filling crucial gaps in community support. Over the past three years, our grant distributions have grown from \$73,000 to \$207,000 per annum, demonstrating the increasing reach of our work.

In 2024, the Foundation allocated \$141,040 in funding to nine community projects, while an additional \$65,960 has been carried over to our 2025 grant cycle. Of this, \$10,000 is already committed to the two-year Share the Dignity project and \$20,000 to domestic violence counselling. The Board will actively collaborate with non-profits over the next 12 months to ensure our funds continue to meet the most pressing community needs.

To our donors, "thank you". Your generosity embodies the vision of the Foundation: giving where you live. If you are not yet a donor and would like to help us reach our \$10 million goal, ensuring at least \$500,000 in annual grants for those in need, I encourage you to speak with one of our Board members. Together, we can make a lasting impact on our community.

OUR HISTORY

The concept for the Mackay Community Foundation began with our founder Scott Alman in 2002. Scott, a partner in a local investment advisory firm, was discussing the story below and thought about the impact on the needy if someone had put away some money for Mackay 100 years ago.

In 1626, Peter Minuit purchased Manhattan Island from the Algonquin tribe of Indians for trinkets worth about \$24. Given the price of real estate in Manhattan today, we could argue that the Indians were swindled. However, let's assume that the Indians invested the \$24 in a bank account returning 6% per year compounded annually.

In 2005, after 379 years, the investment would be worth \$66 billion.

The key founding principal was to give the Mackay Community the opportunity to 'Give Where You Live'. Secondly that money donated would be invested, and together with the growth, the capital would be retained in perpetuity. Each year the growing income is to be given away to community groups, and projects, to assist those in need in our community.

Scott then set about inspiring other key business and community leaders to join the board of the Foundation. The founding board members were; Solicitor Andrew Coates, Accountant Wayne James and Financial Planner Stephen Lowry, with Scott Alman as the chair. Since the beginning the sitting Mayor of Mackay has also held a position on the board.

AT A GLANCE

Since its establishment, the Mackay Community Foundation has awarded **104** grants to local community groups and charities.

As a proud member of Australian Community Philanthropy, we are part of a network of approximately 45 community foundations across Australia — each driven by shared values, ethics, and a commitment to grassroots support in their local areas.

Our Foundation serves the Mackay region, home to approximately 120,000 people, by providing vital assistance to local charities and community groups. We also work diligently to minimise administrative costs, actively seeking donated services and support wherever possible to maximise the impact of every dollar.

GRANTS COMMITTEE REPORT – 2023/2024



Our 2023/2024 grant round invited applications from local non-profit organisations for projects focused on program development, capacity building, and innovative approaches to drive social change and positively impact those experiencing disadvantage.

Through our grants program, the Mackay Community Foundation provides funding to support individuals in distress across Mackay and surrounding districts. We achieve this by partnering with eligible organisations that deliver community education, care services, housing, and personal support through a structured grant application process.

In 2023/2024, the Foundation awarded \$141,040 to a diverse range of community services, including healthcare, support for people with disabilities, community development, women's services, people experiencing homelessness and youth support.

 **Australian Street Aid Project (ASAP)**

Grant: \$41,095

Purpose: This project will be funding a transportable building (12mx3m) next to Chances House and equipment to set up a medical clinic. This will allow people experiencing homelessness to receive free medical care with the help of volunteers and an onsite nurse.



 **Share the Dignity**

Grant: \$20,000 (\$10,000/annum x 2 years)

Purpose: The grant will fund the stock of two Dignity Vending Machines (DVM) in Mackay for two years. A machine provides period products – dispensing 5 packs an hour or 120 packs a day (43,800/year). DVM's will be positioned at the Neighbourhood Hub and CASA.



 **CASA**

Grant: \$19,948

Purpose: The Mackay Homeless Expo is an initiative designed to address homelessness within the community. It aims to provide immediate support to homeless individuals, raise awareness about homelessness and implement long-term solutions to alleviate the issue. This grant has funded the supply of set-up costs of the Expo and packages, such as food, hygiene items etc, for people experiencing homelessness.

 **CQUniversity (U-Beach)**

Grant: \$20,000

Purpose: The project aims to provide beach access and inclusion for children, youth, and adults with disability in the region. Firstly, will be an accessibility audit with Accessible Beaches Australia. Following their recommendations, a range of specialised beach mobility equipment will be purchased and launched for community use with an award-winning U-Beach Community Beach Day.

CQUniversity

Grant: \$5,000

Purpose: The Foundation provided a grant of \$5,000 to support CQ University students in the Mackay region pursuing VET and higher education, by providing emergency financial assistance to those who face unexpected crises that could hinder their studies.

Ronald McDonald House Charities North Aust. (RMHCNA)

Grant: \$12,000

Purpose: This grant to RMHCNA will provide 200 hours of one-on-one tutoring for local students to improve their numeracy and literacy skills, and make the journey back to school as smooth as possible after missing a large amount of schooling due to cancer treatment.

Crossroad Arts

Grant: \$15,000

Purpose: The Foundation provided a grant of \$15,000 to Crossroad Arts that will support the venue hire costs, artists, artist support and Auslan interpreter for the Loose Ends event. This event addresses the gap for inclusive nighttime activities in the CBD for young people with disability and works towards celebrating diversity, access and inclusion.

Kidney Support Network (KSN)

Grant: \$7,997

Purpose: To assist in funding their renal patient transport service, KSN operates Community Op Shops. Two updated, modern Point of Sales (POS) machines will be purchased with this grant to replace the older style cash registers in two of the opportunity shops. The POS machines will allow daily sales to be recorded directly to main office. KSN will also be able to provide new skills to those on placement from job agency networks, likely increasing chances of securing paid employment.

The Neighbourhood Hub (TNH)

Grant: \$10,000

Purpose: Hello Baby! is a weekly social support group for new Mums with babies from birth to 6 months of age to access support, information and support social connections. Each school term, a new group of approx. 15 Mums and Bubs register for the 10 week period (total of 60 new mothers for the 1-year duration). Funding is to pay for external providers to assist with the program, e.g. Deb Rae, Learn to Grow Occupational Therapy, Jody Walker Naturopathy, Woman's Health Physio, Playful Possibilities, and House of She.

NAMED FUNDS

A Named Fund is ideally suited to an individual, family or business wishing to provide support to a range of charities and community groups in Mackay – to leave an ongoing legacy to the community, or honour a family member, friend or outstanding citizen offering some very real benefits to the donor – such as:

- Funds are referenced and acknowledged in the name specified by the donor. This can be an individual, partners, family names, a business name or in the memory of someone.
- The fund is named from the outset, although the initial minimum contribution can be made over a period of years*.
- The donor can participate in the fund as little or as much as they desire.
- Ongoing contributions, whilst not essential, are recommended at least for a few years.
- Donations to the fund are tax deductible.
- Named fund donors can be involved in presenting grants from the fund if they wish.
- The fund continues into perpetuity, even after the donor's passing.

Donors may indicate a preference that a particular group or type of eligible projects benefit from its donation. We are happy to discuss this or any other options with you, confidentially and totally obligation free.
